



Business Simulation Lab

What makes the Financial Markets program unique is the live Business Simulation Lab (Securities Dealing Room) that forms the center-piece of this program. This Business Simulation Lab gives our students the ability to hone their trading and analytical skills in a realistic market environment, using the very same software and tools that are in use at modern dealing rooms the world over.

Business Simulation Lab is the first of its kind in India, and the 6th in the world, for training Program Participants in a real-time, live market environment simulation.

The Lab provides hands-on, real-world training in Securities, Derivatives, Commodities and Foreign Exchange Trading. This setup features actual exchange software from NSE.iT, live data feeds from Reuters and the Industry-standard in analysis and charting tools from Spider Software.

Technology Setup

Today's financial market participants are faced with the challenge of dealing with large volumes of real-time information and data from market conditions, industry & company news, and analyst updates to constantly changing market data. The Institute has recreated this information-rich environment, using the latest in computing and network technology.


